## MEMBER CATEGORIES :

The Club consists of 6 member categories:

### **Active Members :**

must own a French Spaniel and may participate in the activities of the Club. They may participate in the general meetings and have the right to vote. They may be administrators on the board of directors for the Club. Furthermore, they will receive a free annual report and notices from the Club.

### **Spouses Membership:**

they are a spouse of an active member and live at the same address of this active member. They will pay a membership fee that is equivalent to 40% of that of an active member. They may participate in the activities of the Club. They may participate in the general meetings and have the right to vote. They may not however be administrators on the board of directors for the Club.

### **Privileged Members :**

they own a recently acquired French Spaniel puppy and may participate in the activities of the Club. They do not have the right to vote and may not be an administrator or on the board of directors for the Club. As a special promotion the Club will offer them a membership for that current year at 50% of the price of that of an active member.

### **Invited Members :**

anyone who owns a hunting dog (bird dog) and will pay a fixed price of an additional 25% of that of an active member. Invited members have access to our training grounds with an invitation from and must be accompanied by a regular member during their training activities on the Club's grounds. They must respect the same rules of security and safety as the regular members while on Club property. They may not participate in activities reserved for regular members and as a result they may not have the right to vote at the Club's meetings.

### **Benefactor (charitable) Members :**

anyone who wishes to support the French Spaniel Club by way of a donation of a value of one hundred dollars (\$100.00) may be a Benefactor (Charitable) Member. They may not have access to the meetings of the regular members and do not have the right to vote. They may not be on the board of directors for the Club, unless they own a French Spaniel. They will be entered into the Club's electronic mail system and may be invited to participate in certain Club activities.

### **Honorary Members:**

the Club's board of directors may by way of resolution, at an annual general meeting propose the motion of a new Honorary Member to anyone who has donated his hard work or his competence and his loyal services to the Club or to the advancement of the race. The Honorary Member may have the benefit of a life time membership but must use it for their participation in the activities of the Club. They may participate in the general meetings and have the right to vote. They may also be on the board of directors for the Club.
